Dear Business Owner,

What: Road and Footway Closure for Footway Resurfacing,
Where: High Street, Cinderford
When: 2nd January to 15th February from 07:30 to 16:30 (excluding weekends)

On behalf of Gloucestershire County Council, we will shortly be improving the footway at the above location. Please see the map overleaf showing the extent of the scheme. We will be phasing these works in 3 sections as staggered closures which you will see detailed below:

Section 1 – Junction of Valley Road and High Street to Springfield Drive – 2nd January 2024 to 15th January.

Section 2 – Springfield Drive to Lidl – 16th January to 5th February.

Section 3 – Lidl to Market Street Triangle – 6th February to 15th February.

Our programme is dependent on several factors. It can be affected by things like; heavy rain, snow, changes in temperatures and other weather events as well as plant breakdown and unforeseen technical issues that arise once work has begun. All this means **scheme dates and details can change at short notice and without warning. Our apologies for any inconvenience this may cause.**

ROAD CLOSURE

To ensure the safety of pedestrians, road users and our workforce, the road will be closed in sections whilst we work on it. We will be working on one side of the footpath at a time, so whilst one side of the footpath will be closed, the other side will remain open. Any vegetation encroaching onto the footway will need to be cut back. We will do everything we can to accommodate pedestrian access in and out of properties and apologise for any disruption.

Polite note, please don't attempt to walk or drive on any wet surface (freshly laid asphalt) as it may mark your shoes, car and driveways.

Parking

Please note that **parking on the road** (as marked red on the map) **will be prohibited** during the works. We will make every effort to contact the owners of any vehicles left parked on road, but if unsuccessful, we may have to arrange for them to be removed to a secure area until collected by owners. Off-road parking will be unaffected. These works are in place to improve the condition of the road, which you will benefit from, so your co-operation would be much appreciated.

Diversion

We have created an official diversion route which will be signposted and is suitable for all vehicles that would normally use the closed road. We appreciate you may know an alternative route, however, please be aware alternative routes which are outside of the road closure area are used at driver's discretion.


